Our training programme

At Kennedys, we're down to earth

From day one until completion of your training contract you will partake in a structured and dedicated training programme, where you will be given a mix of practical experience and training to prepare you to qualify as solicitors with Kennedys.

Upon joining the firm trainees are paired with a mentor, usually a Kennedys trained mid-level to senior solicitor. The mentor acts as the go to person for you to obtain help and guidance and we also have a partner dedicated to overseeing your training contract.

In order to develop your skills in both contentious and non-contentious work across various practice areas, you will be assigned to four six-month seats with a senior associate or partner acting as your training supervisor during your time in the particular seat. Their experience and guidance will ensure that you are challenged with a varied and high-quality workload.

An appraisal on your performance will be conducted at the end of each six-month seat. We have an open-door policy, and partners and senior associate supervisors are readily accessible.

You will be given responsibility early on. We also encourage trainees, in appropriate circumstances, to continue to work on some of the existing matters when they have moved seats, so that they can work on a case or transaction.

In addition to Continuing Professional Development and Risk Management Education courses required by the Law Society of Hong Kong, you will be given the opportunity to attend in-house and external training seminars.

- **Salary and Benefits**

We offer a competitive salary and benefit package including private medical insurance.
